#### Legal Counsel Report.

Caty Waldrop informed the board that questions previously raised regarding potential overpayment of various survivors' benefits were resolved in a separate memorandum provided to Alan Kelly on 2/2/2021. A. Kelly indicated the memo was sent to all trustees. Ms. Waldrop welcomed questions or concerns from the trustees. No questions or concerns were raised by the Board.

Ms. Waldrop indicated that the annual training for board members will be planned for April. Covid restrictions in April will determine whether the training will be in person or via Zoom.

#### **Taskforce Report**

Ms. Waldrop provided an update on the progress of the Task Force since there was not a Board member present who could provide the report. Ms. Waldrop informed the board that the taskforce met with Cavanaugh Macdonald and RSA. The Task Force discussed the possibility of having Cavanaugh Macdonald conduct a study/review of the cost to members and the city to transition the plan to RSA. Ms. Waldrop indicated the study may extend past the Task Force report deadline set out in the Act, and the Board may want to consider its options under the Act to extend the Task Force to allow for the study to be completed.

Jonathan Jones raised questions regarding checks issued to certain city employees from the pension fund account in error. Alan Kelly indicated that the checks had not been endorsed by approved pension board members and that the account is balanced each month. Susan Snowden indicated that additional control measures have been implemented to ensure this type of error does not occur again.
